The undersigned, being owner of land or lessee of property with access to City gas and water services hereby applies for a City water service connection and agrees to the following conditions:

1. To pay the monthly meter or minimum charge currently in effect, as long as the service remains active regardless of usage or occupancy. (Usage is defined as any volume registered on the assigned meter) **X**\_\_\_\_\_
2. Any changes in rate schedules adopted by the City for either the minimum monthly charge or the additional gas and water rates shall become a part of this agreement, as though fully set out herein. **X**\_\_\_\_\_
3. To pay any late payment penalty, fee or interest currently in effect or as may be adjusted by the City from time to time. **X**\_\_\_\_\_
4. The City may disconnect/discontinue water service due to failure to pay gas, water or other City utility charges. **X**\_\_\_\_\_
5. The City has the right to charge a fee to reconnect gas or water service in the event such service has been disconnected due to late payment/failure to pay water or other City utility charges. **X**\_\_\_\_\_
6. That gas, gas service, water service/water supplied by the City shall be for the sole use of the undersigned; the undersigned shall not extend or permit the extension of pipes for the purpose of transferring gas or water from one property to another, nor shall he share, re-sell or sub-meter gas or water to any other consumer. Each meter service shall supply gas or water to only one residence or business establishment. **X**\_\_\_\_\_
7. No physical connection may be established between any well or private water system/supply and the water system of the City. **X**\_\_\_\_\_
8. Representatives of the City may come upon the premises at any reasonable time to read meters and to inspect or enforce the provisions of this agreement. **X**\_\_\_\_\_
9. Violations of these conditions or other City, State ordinances, laws and regulations related to gas or portable water or water service shall be grounds for disconnections. **X**\_\_\_\_\_
10. Service shall remain in applicant's name and applicant shall be responsible for all water charges until applicant requests service be terminated or water service is disconnected by the City. **X**\_\_\_\_\_
11. Upon termination of services any utility deposit remaining will be applied to the final bill, with any remainder of deposit being mailed to the applicant. If deposit does not cover the final bill the applicant is responsible for any remaining utility balance. **X**\_\_\_\_\_
12. Since new residential customers do not have a history to base average on sewer they will be charged the city average. The City annually calculates sewer rates based on water usage for each residence in January, February and March of each year to avoid charging for lawn and outdoor water use. **X**\_\_\_\_\_
